Agenda item VI. 1.

By: Mr. Jeter. Motion to amend something previously adopted on Term Limits Chapter 3 and 4 (Version C) relative to term limits the City Council and Mayor. Replace with:

Members of the City Council and Mayor shall be eligible for re-election except that no person who has been elected to serve as a member of the City Council for more than two and one-half terms in three consecutive terms that service being during a term of office that began on or after January 1, 2025, shall be elected to the City Council or Mayor for the succeeding term. (Version F)

Mr. Jeter stated he believed that the citizens of Bossier City want term limits, but the issue of retroactivity is not clear. The issue of retroactivity will be resolved by the courts. He believes it is best for the city to include term limits without retroactivity. All 33,000 registered voters of Bossier City will have the opportunity to vote on term limits. Mr. Jeter calls for citizens to vote.

Mr. Lombardino supported Mr. Jeter. He stated he is for term limits but not retroactivity due to the revenge and motive of it.
