The Rescue Partner acknowledges that it has been advised by the BCAC of the medical/behavioral issues that were observed of said animal/s. Said animal/s that have been transferred to the Rescue Partner become the sole property of the Rescue Partner and any and all medical costs incurred thereafter are at their expense.

STERILIZATION OF THE ANIMAL IS REQUIRED UNDER LA R.S. 3:2472.

If said animal/s are not sterilized before leaving the BCAC, the Rescue Partner will comply with state law before the animal/s is/are transferred to a permanent home. Correspondence **SHALL** be sent to the BCAC advising of said procedure.

Sterilization Completion Date: As required by LA R.S. 3:2472, sterilization of the animal is required by Law. The Rescue Partner **SHALL** deliver a letter signed by the veterinarian who performed the sterilization within seven (7) days after the procedure.

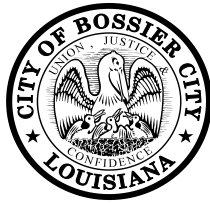

If the Animal dies, is stolen, or is lost during the required time period to complete sterilization, the Rescue Partner **SHALL** send a letter to the BCAC with this information within seven (7) days of death or disappearance. If the Rescue Partner fails to provide a letter to the BCAC from the veterinarian stating that the sterilization has been completed or a letter stating that the animal has died, is lost or has been stolen, then the BCAC will revoke said Rescue Partners privileges to rescue from the shelter.
